

**Dr. Charalampos Dimitriadis** is the head of the research department of the National Marine Park of Zakynthos with a long track record on both research and conservation/management. He has been involved in 15 National and International Scientific Projects (3 as scientific responsible and 1 as lead partner), whereas he has also served as an Assistant Professor at the Technological Institute of Ionian Islands in the field of biodiversity and population dynamics. He is also an external collaborator of the University of Aegean for more than 10 years. His main research interests include marine biodiversity and conservation, community and functional ecology, marine pollution and management and systematic marine spatial planning as well as biostatistics and fisheries and habitat conservation in marine protected areas. He has more than 70 publications in peer reviewed International Scientific Journals and International/National Scientific Conferences as well as a plentitude of publications such as environmental education guidebooks and leaflets, book chapters, video productions and photo books.
